DURING MY TEN YEARS WITH THE ST. PIUS X SOCIETY I FOUNDED, BUILT, BOUGHT OR OTHERWISE ACQUIRED 65 CHAPELS (CHURCHES) OR MASS CENTERS IN THE U. S. AND MEXICO. I ALSO OPENED EIGHT SCHOOLS AND FOUNDED ONE COLLEGE--UNIVERSITY.

SEVERVED AS PRESIDENT OF ST. MARY'S COLLEGE, ST. MARY'S KANSAS FROM 1978-1983

1975--FOUNDED THE ANGELUS PRINTING PRESS AND SERVED AS ITS EDITOR AND PUBLISHER UNTIL 1984.

LEFT THE SOCIETY OF ST. PIUS X IN 1984 AFTER FORCEFULLY OPPOSING ARCHBISHOP LEFEBVRE'S PLAN TO CONCECRATE BISHOPS WITHOUT THE APPROVAL OF THE HOLY FATHER. I ALSO OBJECTED TO SOME ILLEGAL ACTIVITIES BEING ENACTED BY THE NEW SOCIETY OFFICERS FOLLOWING ARCHBISHOP LEFEBVRE'S RESIGNATION AS SUPERIOR GENERAL OF THE SOCIETY OF ST. PIUS X.

PRESENTLY I AM SERVING FIVE TRADITIONAL CATHOLIC CHAPELS THROUGHOUT THE UNITED STATES (NEW HAMPSHIRE, MICHIGAN, WISCONSIN AND NEW MEXICO).

I ALSO OPERATE AN ADOPTION AGENCY FOR UNWED MOTHERS AS AN OPPOSITION TO ABORTION *see Doc 26*

THIS DOCUMENT ATTESTS TO THE FACT THAT THE ORGANIZATION I BELONG TO IS RECOGNIZED BY THE FEDERAL GOVERNMENT OF THE UNITED STATES AS A LEGITIMATE RELIGIOUS CATHOLIC ORGANIZATION WITH FULL TAX EXEMPT STATUS AND ENTITLED TO ALL SUCH PRIVILAGES.
